



## Attorney Donald R. Jackson Sr.

June 26, 1938 - November 20, 2024

Long-time attorney and civil rights leader Donald R. Jackson Sr., 86, passed away November 20, 2024, in Peoria. He practiced law more than 50 years, served as president of the NAACP's Peoria branch two decades and president of the Illinois State Conference of the NAACP from 2004 to 2011. With his wife, the late Ernestine Jackson, he forged a legacy of advocacy and activism.

Born June 26, 1938, in Peoria, IL, to Edward Jackson and Kathlyn Williams, he was a descendant of one of Peoria's earliest families. His great-great-grandfather, Thomas Lindsay, came to Peoria as a boy in the 1830s. Lindsay, Peoria's first Black market master, was part of a small group that successfully pushed to integrate public schools in 1871. His great-grandfather Henry Gibson, a constable and Peoria's first known Black elected official, won Peoria's first civil rights lawsuit. His great-grandmother, Julia Lindsay Gibson, was a businesswoman and founding member of several long-standing local organizations, including the Colored Women's Aid Club, which organized what eventually became Carver Community Center.

Don married Ernestine Humes January 21, 1961, at the former St. Patrick's Catholic Church. She preceded him in death September 6, 2023. He was a veteran of the U.S. Navy.

Whether in the courtroom or on the golf course, he loved to argue. It was a trait, along with his oratorical skills, that served him well in his life-long drive for social and political change.

“Don was a kind of crusader in that he cared more about justice than making money,” says friend and colleague G. Douglas Stephens.

He was equally focused on fighting racial discrimination and building opportunities in education, employment, housing, healthcare and politics. Both publicly and behind the scenes, he was influential in mentoring or kick-starting the careers of a generation of Black lawyers, judges and some of the city’s most prominent elected officials. He formed the city’s first Black law firm, which operated in the 1980s, with Clifton Mitchell and now-retired Judge Glenn Collier. Illinois’ two U.S Senators regularly appointed him to serve on screening committees assigned to review and vet candidates for federal judgeships or attorneys in the Central District of Illinois.

In his later years, he was probably best known for his volunteer work with the NAACP, but he had already built a significant private practice specializing in many of the same issues he targeted with the NAACP, particularly labor law, civil rights and all forms of job discrimination. He was one of the few area attorneys who consistently represented workers and unions in workers’ rights cases. He has also worked on cases of wrongful convictions and wrongful arrests.

He was a 1956 graduate of Manual High School and, later, a graduate of Bradley University. In his early 30s, with three young sons and his wife’s support, he decided to go to law school. At the time he was a recruiter for the Tri-County Urban League’s pioneering Labor, Education, and Apprenticeship Program (LEAP), which helped more than 200 women and minorities gain union jobs in the construction and building trades.

He graduated from the University of Illinois College of Law in 1974 and returned to Peoria to work for the National Labor Relations Board. He was also admitted to the bar in 1974. A year later, he entered private practice and joined the staff of the Peoria County Public Defender.

He taught part-time at Bradley University, served as guest lecturer for seminars at agencies such as the Illinois Department of Human Rights, and as a hearing officer for the Illinois Supreme Court's Attorney Registration and Disciplinary Commission.

Civil rights and the law were not his only passions. He was an avid golfer who played with the Peoria Progressive Golf Club for many years. He and his wife were founding members, as well as board members, of the Heritage Ensemble and he was a former co-owner of Big John's North with Stephens and Paul Mroz. He was a member of St. Vincent de Paul Catholic Church.

He received numerous awards and honors through the years. They include the Peoria County Bar Association's (PCBA) Distinguished Service Award in 2006, the PCBA Diversity Committee's Legend Award in 2022, and the PCBA 50-year Service Award in 2024. In June 2024, he was among the first group inducted into the Manual High School Athletic and Distinguished Alumni Hall of Fame. He has also received the Heritage Ensemble's Bridge Builder Award, the Martin Luther King Holiday Committee Commemorative Service Award, and the ELITE Youth Outreach Lifetime Achievement Award.

A member of the Peoria County Bar Association and the Illinois Bar Association, he served on many boards and committees, including the City of Peoria's Advisory Committee on Police-Community Relations and the Peoria Citizens' Committee for Economic Opportunity Board of Directors.

Survivors include three sons, Donald Jackson Jr. and Dale (Diane Linda) Jackson, both of Peoria, and Deric (Hannah Puffer) Jackson of Plymouth, MN; two brothers, Edward Jackson Jr. and James (Mary) Jackson, both of Peoria; six grandchildren, Desirae (Duane Simmons) Jackson, Mario Jackson, Sofia Puffer Jackson, Lewyn Puffer Jackson, Tiffany (Dominique) Hobbs, and Randy Jackson Jr.; 12 great-grandchildren, Trinity, Leiana, Le’Naya, D’Ahira, Analya, T’Ayla, Delano, Randy III, Jathaniel, Kaidyn, Marie, and Serenity; three great-great-grandchildren, Aubriella, Akai, and Angel; and many nieces, nephews, family and friends who loved him.

Besides his wife, Ernestine, he was preceded in death by his parents, his stepfather, Francis Williams, stepmother, Alice Jackson, and one sister, Patricia Perry.
